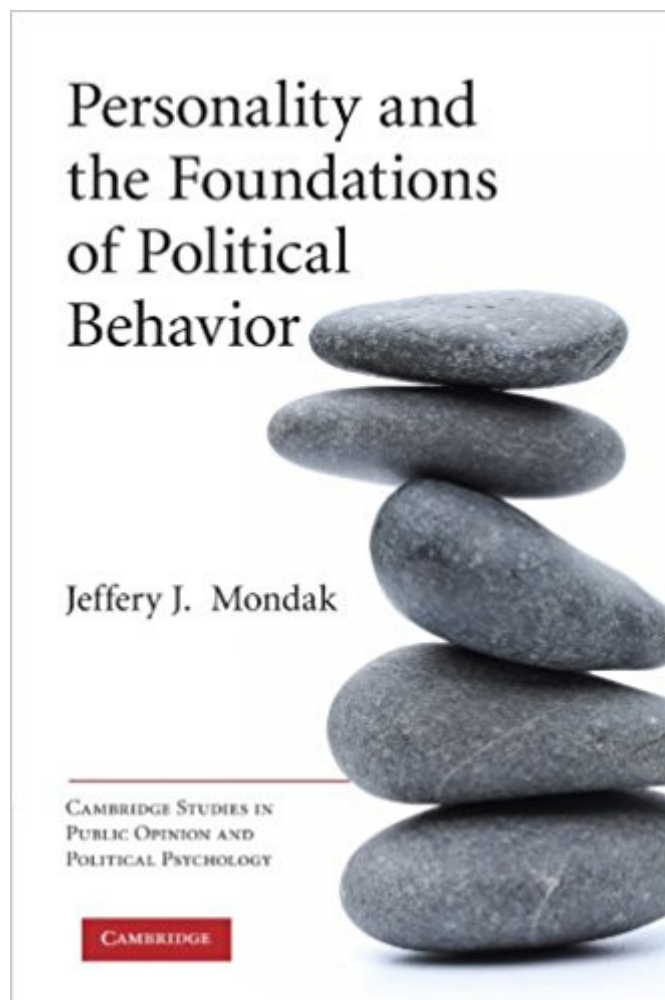

Development of such holistic accounts is critical, Mondak contends, if inquiry is to move beyond simple "blank slate" environmental depictions of political engagement. Analyses examining multiple facets of political information, political attitudes, and participation reveal that the Big Five trait dimensions - openness to experience, conscientiousness, extraversion, agreeableness, and emotional stability - produce both direct and indirect effects on a wide range of political phenomena.
