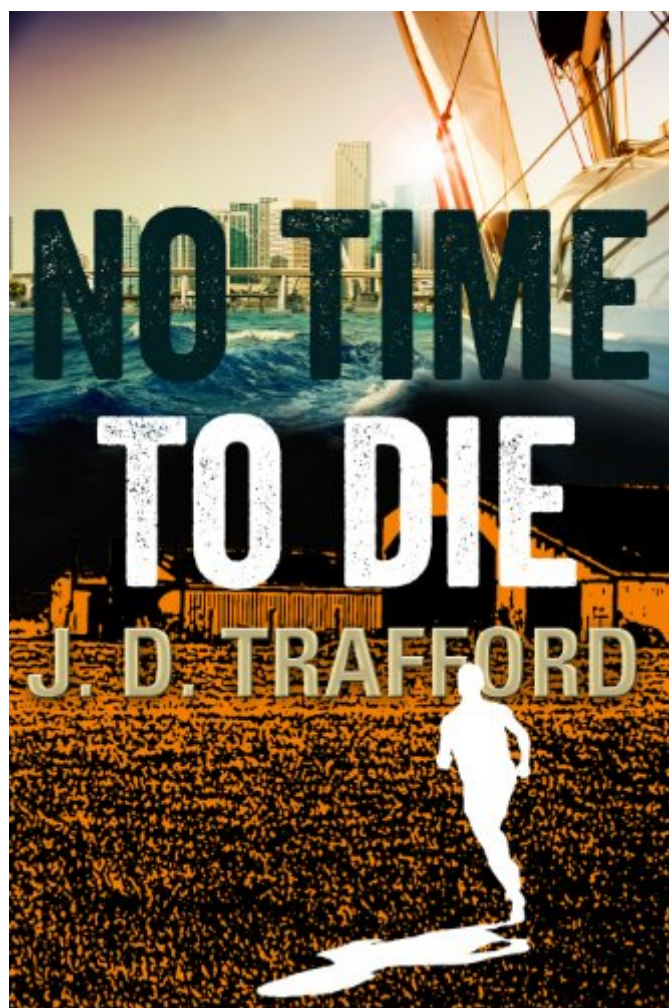

I started reading this book at the end of J.D.'s first book, "No Time To Run", and as soon as I finished reading those first few chapters ~ I immediately purchased this (No Time to Die). I read it easily in one day, as I simply could not put it down until I finished reading it. I found the characters so real and loved this book, as well as the last book took me to. I have lived near the ocean a lot (as in his first book), as well as in various areas of the world. J.D.'s style and descriptions transports you

as if you were there with his characters. I eagerly wait for his new book to be available this week through , I believe.

I liked the book for the most part. I love to read books that have on-going characters and I had just finished the first Michael Collins book so wanted to see what was next for Michael. I thought everything went at a good pace, although I was a little lost about why his girlfriend broke up with him. I think it must have happened "off-screen" between books 1 and 2 so was confused when I started reading it. Not sure if I'm happy that Michael has gotten away with stealing but for now, it makes for a good read. I loved the hippie character. I kept seeing this book as a movie and I saw him as Kramer from "Seinfeld".

Big disappointment from book 1. Tired old theme about migrant workers mistreated by greedy owners and a corrupt deputy. Collins doesn't do much except tag along. Kermit is annoying. I don't find his character amusing. Good news is that book 3 is much better, worth the read to complete the series.

This book was my least favorite of the three in this series. I wanted so much to like it because I thoroughly enjoyed the first book AND the third (my favorite). I was disappointed that Andie and Michael had split up when she was such a pivotal character in the first book, didn't care for Kermit, and though the story line was there, it was just okay in my opinion. I skimmed the book having lost interest. I do recommend reading, however, before moving on to the final book.

Michael and Kermit hit the road again . Action and suspense with Kermit.'s humor still in tact. Justice may be successful in some cases. Great read!

I've really enjoyed J. D. Trafford's first book in his series of two, as it held my attention, and he seems to have a real knack for writing - much in the style of John Grisham. I liked this first book so much that I immediately bought the second, and am finding it to be equally excellent.
