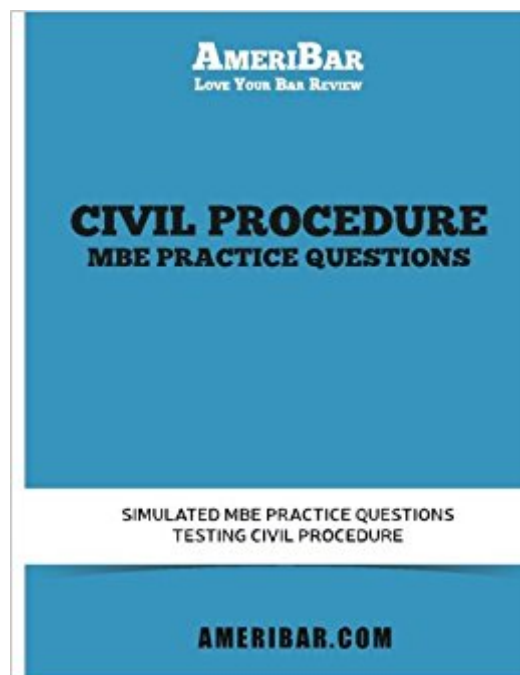

This is not an outline - this contains Questions and Answers (and explanations) ONLY. (264 Questions and Answers) I am torn between giving a three and four star review. Good for getting to know the rules but not so good at giving a realistic look at possible MBE's on the real exam. I purchased this along with "Mastering Multiple Choice for Federal Civil Procedure" (West Academic.) Neither of these two have an outline. They are just questions and answers. The 264 "MBE's" in this book seem way too EASY for MBE's. Keep in mind that we haven't yet seen real MBE's (as of Jan 2015) other than the ten questions released by the NCBE, but compared to the MBE's I've seen in other subjects these questions are way easier than real MBE's. I got about 85% of the questions correct, and CivPro is my worst subject. This book will help you learn the rules because the questions are just really basic flashcard type questions about the rules. It takes no time to burn this book so I kind of liked that as it helped me learn but didn't take up a ton of time. But I don't think they are representative of what you will see on the Bar Exam. \*\*\*\*\*NOTE\*\*\*\*\*

\*\*\*\*\*I just completed the 50 questions from Wolters Kluwer's "MBE Civil Procedure Questions"

and feel they are as close to what a real MBE looks like as any CivPro MBE's I've seen. It is well worth the money. That book is not currently available on but can be purchased for \$30 through Aspen Law's website. The questions simulate MBE style and provide in-depth explanations for each choice, explaining not only why the correct choice is correct, but also why the incorrect answers are not."\*\*\*\*\*Update - Now that I have seen actual CivPro questions on the Feb 2015 MBE I can report that this book contains a lot of questions that are far easier than what was on the exam. A lot of them aren't even written like the MBE questions and/or the answer choices are not similar to the MBE. Quite a lot of the questions in this book are flashcard style questions, where as the MBE questions are much more complex. Some of the questions are similar to the MBE but a good number are not, which won't help you when prepping to take the exam any more than simply reading flashcards.Here is an example of question that is much easier than anything on the MBE:Question 113: A driver and a trucker are involved in an accident on a state road. The driver sues the trucker in fed court, alleging that the trucker's negligence caused the accident. The case proceeds to trial, and the jury returns a verdict, finding that the trucker was liable for the damages resulting from the accident. What type of verdict did the jury return? A) general verdict, B) basic verdict, C) special verdict, D) inconsistent verdict.--MBE questions very rarely have such simple answer choices. They usually include "only if"s and "because"s.There are a lot of questions in this book with answer choices that are far simpler than the MBE. Here are some examples:Question 80: A) preponderance of the evidence, B) beyond a reasonable doubt, C) de novo, D) abuse of discretion.Question 252: A) In personam, B) In rem, C) Quasi in rem, D) Quasi in personam.Again, it is rare for the MBE answer choices to be this simple.All in all, I think this book is a good tool, especially for the price and have upgraded from a three star to a four star, but would still recommend Wolters Kluwer's "MBE Civil Procedure Questions" (only available through Aspen Law's website for \$30) as the closest thing to real MBE questions.

Useful to learn and remember the FRCP. Going through the problems really helps ingrain the rules. However, the problems are not similar to normal MBE questions (these are much easier). Basically, if you need help memorizing the rules, this is a good resource; if you want practice going through Civ Pro MBE practice questions like what you'll see on the Bar, this is not a good resource.

For the number of questions you're getting with this book, it has great value. However, the questions are nothing like the real MBE. I used this book to study Civ Pro along with *The Multistate Goat: The Essential Book of MBE Practice Questions* for the NJ Bar in July 2015 (and I passed, thank goodness!). So, while I found the questions great practice in so far as learning the black letter law, I wanted to warn the buyer to expect the actual Civ Pro MBE questions to be more complex and nuanced than the simple questions we're getting here that deal with singular topics (i.e. Subject Matter Jurisdiction, Forum Non Conveniens, etc.). Still, for the price, it's a great value for 264 questions plus answers and explanations that you're getting.

I'm not giving this product 5 stars as an MBE review tool - as other posters have explained, it doesn't at all resemble MBE questions. However, I am using it as a "baby step" refresher guide that I'm working through during my final year of law school to refresh myself on the concepts that I may have once known so that, come BarBri time, I am at least a little familiar with the underlying concepts and I don't have to completely start from scratch. Plus some of the questions are so easy that it's kind of an ego boost, too. But, to reiterate, do NOT rely on this as your only source for MBE civil procedure.

This absolutely helped me get through the civ pro questions on the MBE. Perhaps these questions weren't as "complicated" as the real MBEs, however, it's a GREAT way to drill the rules during your study sessions. There was no civ pro question on the MBE I didn't feel I was prepared for. Absolutely recommend.
